April 19, 2012

APPROVAL OF MINUTES:

President Long asked if the members of the Board had received their copy of the minutes of March 15, 2012 and whether there were any corrections or additions. Hearing none, Mr. Howard Miller moved, seconded by Mr. Johnson, to approve the minutes. Motion unanimously carried.

FINANCIAL REPORT:

Treasurer Ann Nichols reported the financial statement for March was posted to the Board website for review. Treasurer Nichols moved for acceptance of the March 2012 financial statement and payment of the April 2012 bills. Mr. Howard Miller seconded the motion, the motion unanimously carried.

PRESENTATIONS:

FEDERAL LEGISLATION

Mr. Broderick reported Mrs. Arbogast was unable to attend today's meeting. Mrs. Arbogast submitted a written report, which Mr. Broderick reviewed the following:

The House is moving quickly in its election year budget process, having passed a budget blueprint and assigned a six-member task force to begin looking for the substantial budget cuts which will be necessary to implement in 2013 because of the failure of the "supercommittee" to reach a long-term deficit reduction agreement late last year.

In addition, the House Subcommittee on Energy and Natural Resource Development scheduled its markup of the FY '13 bill for the Bureau of Reclamation, Army Corps of Engineers, energy programs, and some defense issues for Wednesday, April 18. Appropriation markup on the Energy & Water Appropriations Bill did not provide a specific number for the Arkansas Valley Conduit (Conduit). Reclamation's budget was cut \$89 million below FY12, and the budget was cut \$47 million below the President's request. As this time individual line items have not been cut.

Federal lobbyists are monitoring discussions about wilderness designations, most recently re-initiated by Senator Udall's announcement to have grass-roots level discussions with interest groups. Federal lobbyists do not expect movement on any wilderness legislation in the remaining months of this Congress.

CONDUIT, EXCESS CAPACITY MASTER CONTRACT, AND NEPA UPDATE

Jean Van Pelt reviewed the following:

- The EIS continues to move forward on schedule.
- Update on the field surveys that are being performed by Reclamation.
 - Reclamation has completed the aerial photography of the various alignments for the Conduit.
 - This week they began the cultural resource surveys.
 - Will begin the geotechnical sampling by the end of April.

- Reclamation has identified the preferred alternative for the draft EIS and is currently preparing an official statement.
- Staff continues to review the draft EIS chapters and appendices.
- A meeting with the Cooperating Agencies is scheduled for Tuesday, May 15, at the District office.
 - Purpose is to review the agencies comments on the draft EIS Chapter 4 Environmental Consequences.
- Arkansas Valley Conduit Participants Upcoming Meetings will be scheduled for the end of May.
 - Purpose is to review the Water Conservation Plan and results of the participant's water system audits.
 - o Audit
 - o Meetings to be held in Wiley, La Junta, and Manzanola.

PROJECT WATER UPDATE

Roy Vaughan provided a PowerPoint presentation reviewing the following:

- As of April 16, there was 243,447 acre-feet stored in Pueblo Reservoir; 152,768 acre-feet of Project water; 44,611 acre-feet of Excess Capacity water; 46,631 acre-feet of Winter water.
- There is currently 104,181 acre-feet of Project space in Pueblo Reservoir and 59,033 acre-feet of space in Turquoise and Twin Lakes Reservoirs.
- Project Reservoirs: Turquoise 94%; Twin Lakes 96%; Pueblo 124%.
- Arkansas River Basin and Upper Colorado River Basin Time Series Snowpack Summary.
- SNOTEL Snow Water Equivalent as Percent of Average.
- Import forecast:
 - February 45,200 acre-feet
 - o March 53,300 acre-feet
 - o April 23,100 acre-feet

Mr. Vaughan shared photos of the roads up to the collection system, which show a lack of snow, and the work Colorado Springs Utilities is doing at the Pueblo Dam on the Southern Delivery System project.

Mr. Witte reviewed the process in the event there are low imports, that affect the return flow acre-feet amounts. Dan Henrichs explained his concerns pertaining to agriculture when there are low imports.

Mr. Broderick reported meetings continue on the Ruedi Reservoir issues, a meeting will be held on April 23 in Denver. Federal lobbyists and District staff have been interfacing closely with Bill McDonald and with Washington, D.C.-level Bureau of Reclamation staff as proposals to address the debt issues develop. The Colorado delegation is being updated of the discussions.

President Long asked if there were any other matters to come before the meeting, and hearing none, adjourned the meeting at 12:28 p.m.
