- There is currently 114,742 acre-feet of Project space in Pueblo Reservoir and 34,154 acre-feet of space in Turquoise and Twin Lakes Reservoirs
- Charts illustrating storage amounts in Turquoise, Twin Lakes, and Pueblo Reservoir
- Project Reservoirs: Turquoise 86%, Twin Lakes 93%, Pueblo 112% as of November 12, 2020
- First Use Project + PCO Municipal Water
- Total M&I PW in the system is 128,925 as of October 31, 2020
