WATER COURT RESUME

Mr. Hamilton reported Case No. 13CW19 is an application for Approval of a Plan for Augmentation by St. Charles Mesa Water District (SCMWD) and was mentioned in the April 2013 Board Water Court Resume Information Item as a case of interest to the District. The sources of water for this plan are Bessemer Ditch Water Rights and Fryingpan-Arkansas Project water and Project water return flows. There are two zones within SCMWD and Zone 2 is mostly (if not all) outside of the District boundaries. Staff, general counsel, and special water counsel have discussed this case and believe there are sufficient issues concerning the use of Fry-Ark Project water that a Statement of Opposition should be filed in this case. Alix Joseph said the attorney for SCMWD has contacted District legal counsel and have begun discussions to address the District's concerns with this application.

Mrs. Ortegon moved, seconded by Dr. Moore, the Board authorize special water counsel to file a Statement of Opposition in Water Division 2, Case No. 13CW19. Motion carried, with Mr. Simpson abstaining.

U.S. BUREAU OF RECLAMATION REPORT

Roy Vaughan provided a PowerPoint presentation reviewing the following:

- As of May 14, there were 165,860 acre-feet stored in Pueblo Reservoir; 123,431 acre-feet of Project water; 32,441 acre-feet of Excess Capacity water; 9,831 acre-feet of Winter water.
- There is currently 133,518 acre-feet of Project space in Pueblo Reservoir and 60,515 acre-feet of space in Turquoise and Twin Lakes Reservoirs.
- Project Reservoirs: Turquoise 39%; Twin Lakes 81%; Pueblo 89%
- Time Series Snowpack Summary for Upper Colorado River Basin and Arkansas River Basin
- Snow Water Equivalent Graphs for Independence Pass, Ivanhoe, Nast Lake, and Kiln
- Forecast: February 32,900 AF; March 25,700 AF; April 24,700 AF; May 47,231 AF

DIVISION ENGINEER'S REPORT

- Current River/Reservoir Operations
 - Low flow conditions
 - (1) Run-off appears to have begun on Monday 5/13/13
 - (2) Inflow increase at Portland observed Wednesday 5/15/13
 - (3) Numerous releases of Winter water (Bessemer, High Line, and Oxford currently, but Catlin, Holbrook, and Fort Lyon have run out of their Winter water)
 - (4) Exchanges / alternate point of diversion into Pueblo 70 cfs
 - (5) Upstream Exchange 118cfs
 - (6) Increased transit losses
- Reviewed Rule 14 Replacement Plans to replace well depletions.
 - o Total temporary pumping approvals:
 - (1) AGUA 5466 (2) CWPDA 14,666 (3) LAWMA 10,132
 - o Replacement supplies will be needed to preserve the ability of a number of municipal and domestic well users who are members of CWPDA.

- o LAWMA has submitted plan to address in-state replacement deficit.
- o Final approvals will be issued following District allocations, May 16, 2013.
- Two applications for approval of Rule 10 Plans have been submitted, one by the Lower Arkansas Valley Water Conservancy District (LAVWCD) and a second plan specifically addressing improvements under the Ft. Lyon Canal system under the auspices of the LAVWCD.
 - Both plans state their intention to rely on Fry-Ark return flows to be used as a source to maintain return flows associated with surface water irrigation improvements.
 Additionally, the LAVWCD intends to utilize two recharge ponds as means of maintaining return flow patterns.
 - o Both plans were approved on April 30, 2013.

President Long congratulated Mr. Witte on receiving the Bob Appel Award at the Arkansas River Basin Water Forum.

U.S. GEOLOGICAL SURVEY REPORT

Mr. Mau presented a PowerPoint titled, *Summary of Water Conditions in the Arkansas River Basin*, reviewing the following:

President Long said Chris Woodka did several great articles last week regarding farming in Bent County, and suggested reading them.

STATE LEGISLATION UPDATE

Lee Miller reported the General Assembly adjourned on May 8, 2013. On the final day of the session, the General Assembly passed two pieces of legislation that the District has been following. HB03-1130, sponsored by Representatives Fisher and Sonnenberg was passed accepting amendments made by a conference committee. This bill allows the state engineer to reapprove operation of an interruptible water supply agreement. Also passed on the last day was HB03-1248, which, as amended, authorizes the Colorado Water Conservation Board (CWCB) to administer a pilot program to demonstrate the practice of fallowing agricultural irrigation land and leasing the associated water rights for temporary municipal use. The bill was signed by the Governor on May 13, 2013. SB03-19 was signed by the Speaker of the House, and no further information is known at this time.

The Board was provided a copy of the D 2013-005 Executive Order, directing the Colorado Water Conservation Board to commence work on the Colorado Water Plan. Lee Miller read paragraph III B. as follows:

The CWCB is directed to commence the work necessary to submit a draft Colorado Water Plan for review by the Governor's Office no later than December 10, 2014. The CWCB will work with the Governor's Office to complete the final plan no later than December 10, 2015.

NRCS COLORADO BASIN OUTLOOK REPORT MAY 1, 2013

Mr. Hamilton reported the Colorado Basin Outlook Report for May 1, 2013 was posted to the Board website and a copy was in their Board binders. Mr. Broderick said this item will move to an information item in the future.
